ARTICLES OF INCORPORATION
OF
LUTHERAN CURSILLO OF SOUTHERN CALIFORNIA
CALIFORNIA RELIGIOUS CORPORATION

ONE: The name of this corporation is Lutheran Cursillo of Southern California.

TWO: This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law primarily for religious purposes. The specific purposes for which this corporation is organized are to develop a lay ministry to the Lutheran church community in Southern California.

THREE: The name and address in the State of California of this corporation's initial agent for service of process is Mike Dettmer, 9906 Lido Way, Cypress, Ca. 90630.

FOUR: (a) This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
